Transfer of Business Entity

Dear valued customer,

We would like to inform you that ISO Certification/Training department of Bureau Veritas Singapore Pte. Ltd. (BVS) will be transferred to Bureau Veritas Quality Assurance Pte Ltd (BVQA) under Bureau Veritas Certification Holding with effect from 1st May 2021.

We have decided to register the certification business of Bureau Veritas Singapore Pte Ltd (BVS) as a separate legal entity called Bureau Veritas Quality Assurance Pte Ltd (BVQA) to strengthen our governance and to further demonstrate Bureau Veritas' commitment in complying to IEC ISO 17021. This will further enhance on impartiality in conducting audits when it resides in, and eliminate the risk of conflict of interest amongst Bureau Veritas' businesses.

What to expect

1. The company name and legal entity has changed from Bureau Veritas Singapore Pte Ltd to Bureau Veritas Quality Assurance Pte Ltd. Our Organization, Processes and Accreditations remain the same. There is no change to our auditing processes and the competency of our auditors.
2. We have obtained Approvals for BVQA to issue valid UKAS and SAC (Accreditations) Certificates.
3. All Certificates issued under BVS remain valid with all accreditations until the certificate's existing expiry date.
4. Ongoing certification / re-certification / surveillance processes will proceed as normal under BVS/BVQA and the transition will only take place on the completion and issuance of certificates.
5. Our Technical Team will communicate directly with clients with regards to the certificate issuance/re-issuance.
